

MINUTES FROM THE 139th ANNUAL MEETING JANUARY 27, 2019

Following worship service, everyone in the congregation was invited to gather in Perkins Hall for the annual meeting which was preceded by a potluck meal. Administrative assistant, Julie Jaquette, was again recognized as being an "annual meeting birthday girl."

At ll:52 a.m., Moderator Patty Lantrip called the 139th Annual Meeting of the First Congregational Church, United Church of Christ, Prescott, Arizona, to order. A quorum of 37 was established. In all, there were 58 members present in addition to many guests.

Pastor Jay Wilcher opened the meeting with prayer. He then led us in remembering those of our congregation who have passed in 2018, sharing a personal remembrance of each: Kevin Nelson, Pat Welch and Marilyn Lummel.

The minutes of the 138th Annual Meeting of FCC of January 28, 2018 were approved.

Julie McCurdy, treasurer, said that the open budget review held last Sunday after church was very productive with responses to questions on many of the budget items which included the following expenses: custodial, van insurance and maintenance, marketing, security guards, music supplies, outreach, and OCWM. Regarding the 2019 budget, Pete Norum made a motion to increase our Southwest Conference support, OCWM, from the budgeted \$3,600 to \$7,000. Discussion ensued. The following comments were shared: From Gary Gard: our present mission outreach exceeds \$21,000 and that this is 8% of the budget. From Susan Lemons: our present budget is a deficit budget as it depends on \$108,000 from the FCC Foundation. The motion was not approved.

The proposed budget for 2019 was unanimously approved.

Al Beeson, FCC Foundation, reminded us that the Foundation exists as a separate entity to "support this church". He announced that Jay Eby, after 12 years of service on the Foundation, has retired. Jim Christopher is a new member on the board. There are presently ten endowments comprising funds in the Foundation. He stated that, "More legacy gifts will be needed to support the church for years to come."

I served as president of the board of CCJ (Coalition for Compassion and Justice). It was a great year as we focused on providing housing for the homeless. Our partnership with Dorn Homes gave birth to two lodge models being constructed for future residents. My involvement is an extension of your ministry in our community.

It was a tough year as we had prominent members of our church family pass away – Marilyn Lummel, Amy Wilson, Mardell Hull, Ron Solt, Sylvia Neely, and Marilyn Eby. They will all be missed. We will continue to remember their gracious presence with us, and all they did to bless our church family.

Living in Arizona and Prescott, there are always people moving away from us to be near family, and others arriving from other places. This year was no different. We said "goodbye" to members who will be missed and said "welcome" to others who have joined us. It seems the only constant is change, but our other constant is God, who has kept this congregation going since 1880! We look forward to celebrating our 140th anniversary in September of 2020.

Some main happenings The **church van** became a future viable source of income and was listed for sale and later sold. Natalie Brummer became our church's **Member in Discernment** and has been faithfully supported all year. A new **microphone system** was needed and installed (and now a new **video system** is almost complete).

Patty Lantrip, Revered Ralph Wagner and Pastor Jay attended the **Annual Southwest UCC Conference** in Phoenix. This annual meeting is open to any member of FCCUCC and partially subsidized for attendees.

A **Long Term Planning Committee** was organized and a meeting followed to brainstorm along with the recent survey to the congregants to gather facts and opinions on our church's future. The **Pancake Breakfast** committee was also formulating and planning began along with the decision that all the proceeds to be given to Discovery Gardens Preschool. Enough was raised to pay tuition for one year for a needy student.

The planning of a special **Women's Fellowship Tea** was launched with a wonderful and successful turnout at the home of Ronda Hatfield. Our first **Art Show** captured the attention of some talented artists as well as many customers.

One big upcoming celebration is our **Church's 140th anniversary** coming this fall, which has already been discussed. A committee chaired by Barbara McCollough is be forming soon.

Pastor Jay's long awaited **sabbatical** (June-August of this year) has committee members already making plans for Pastor Jay's absence.

Well, besides the above church activities, various Cabinet decisions were made to strengthen our community involvement (DACA for example). I've had many challenges that I've tackled with perseverance and truly through the grace of God and much support from YOU.

TREASURER

December 31, 2019

The budget for 2019 anticipated expenses totaling \$251,265. Actual expenses reached \$253,885. Funding for most of these expenses came from Foundation transfer (\$85,000 for minister and \$23,000 for Education) and Favour Funds (\$6,000 Education Director). The remaining (more than \$146,000) was anticipated from generous pledges and contributions from our congregation and from facility usage (outside groups), memorials and weddings.

Below is a recap of 2019 finances, with a few highlights:

Income versus Expense:

Income as of December 31, 2019 is \$271,921

- \$132,333 from pledges and other contributions
- \$25,588 from facility use and other income
- \$114,000 transferred from Foundation and Favour Fund

Total expenses as of December 31, 2019 are \$253,885.

Total income has exceeded expenses by \$18,036.

Budget versus Actual:

Income at year-end reached 102% of the overall income budget of \$260,000.

- Income from offerings is 103% of that budget
- Income from facility use is a 128%
- Transfers from both the Foundation and Favour Fund are at 100%

Expenses at year end are at 101% of the expense budget of \$251,265.

Budget Highlights:

Non-budgeted Income:

Sale of Church Van to Yarnell Fire Department brought in \$7,000.

TREASURER continued

Non-budgeted Expenses:

- The cost of our sound system repair/upgrade was **\$5,000**. Members of the congregation generously donated \$3,145 and the remaining \$1,855 was spent from Payne Fund.
- New Video system cost was **\$4,600**. Congregation members again generously donated \$2,930 and the remaining \$1,670 spent from the general operating account.

Special note for 2020 budget:

Based on input from the Long-Range Planning Committee and Foundation Board, the 2020 budget committee was tasked with preparing a proposed budget based on significantly reduced funds from the Foundation. As such, many of the ministries and some employee budget areas were reduced to accommodate operating with only \$51,000 coming in from the Foundation in 2020.

THE THEME OF THE 2020 STEWARDSHIP CAMPAIGN IS "CELEBRATING 140 YEARS"

Since our birth in 1880 we have tried to be people of justice, compassion and inclusivity in our community beginning with our ministry to the Chinese who lived along Granite Creek. During 2019 we have continued that tradition in many ways including hosting a community wide forum on race relations, sponsoring a DACA student and standing up for refugees both at our nearby border and around the world.



The spirit is moving among us, thanks be to God. That movement is calling us to a deeper walk of faith with our leader Jesus of Nazareth. Our money is one part of that faith. Please prayerfully estimate what you believe God is leading you to, by faith, give to First Congregational Church of Prescott for the year of 2020.

We have collected 33 pledge units. This means that couples pledging together constitutes a single unit. Out of those pledges, 33 of them were Members of our church, with 10 additional units from Friends and Regular Attenders.

The adult education portion of the position has not taken off, although several people who are enthusiastic about their own interests gave some interesting and moderately well attended workshops. I think encouraging and supporting individuals who want to present is a productive path.

As part of my role as education director, I have displayed books from the library in Perkins Hall. I change this to go with the seasons or selected topics.

I organized two "Nine 'n Dine" events. Both times drew about 36 people and four hosts. The feedback on these was positive.

FOUNDATION

JANUARY 13, 2020

The purpose of the Foundation is to receive, invest, manage, operate and distribute charitable gifts and other forms of property for the benefit of the sole member, The First Congregational Church of Prescott.

The Foundation is managed by a Board of Directors. There are 7 elected members and two unelected members, the Pastor and the Chair of Physical Resources. The 2019 officers were Al Beeson, President, Angela Imbierowicz, Vice-President, Susan Lemons, Treasurer and Jim Christopher, Secretary.

Currently the Foundation assets are the funds deposited in local OneAZ Credit Union, funds in the United Church Funds and the Building leased to the Prescott Station. The total assets (un-audited) as of the end of 2019 were \$1,423,995. Of those funds the Building is \$513,340. Many of the funds are restricted. Of those funds there is approximately (un-audited) \$280,754 available.

In 2019 the Foundation provided \$108,000 in support of the Minister's Salary and the Christian Education program wages and expenses. The Foundation also pays for insurance, real estate taxes on the Prescott Station, the CPA who reviews the foundation books and other legal expenses.

Prescott Station has won another year of outstanding restaurant in the area and continues to be a wonderful tenant. This year the Prescott Station has had some water problems due to the rain and snow melt on the East side of the building. We are working with them to find a solution. There have also been issues with the sewer lines needing to be cleared often, as they are so old and under the parking lot.
