142nd Annual Meeting of First Congregational Church UCC Prescott January 23, 2022, 11:22 AM.

Presided by Co-Moderators Bill Bryant and Melissa Gates.

Establishing a quorum: Each congregational member that had not voted by hybrid email stood and announced their number in numerical succession to establish a quorum. The formula for establishing this quorum requires 30 percent of 107 members = 33 congregational members. 21 members voted by email and 3 were hand-presented at the meeting for a total of 24 pre-voting members. The required number of 9 remaining voting members were present. A Quorum was reached.

2022 Budget: Comments from members were received. The insurance reimbursement was the only monetary transaction taken from the Foundation, as several years ago there was a decision to have a more responsible budget independent from the Foundation. We still utilize the funds from our reserves. The motion to approve the 2022 budget passed unanimously.

PROPOSED BUDGET FOR 2023

The proposed budget for 2023 portrays a story of exuberant optimism. After several years of reining in the expense budget to the minimum requirements to keep our church financially sound, this year we want to live out our expectations for visioning and allow for new (or renewed) ways of learning, giving and welcoming. With this in mind an amount of \$20,000 has been designated for Visioning expenses. The future is wide open!

Additional expansion to the expense budget includes a 10% increase to nearly all expense items. The increase is necessary to offset rising costs and to allow for more freedom in our expression of Ministry.

The 2023 income budget also expresses that same exuberant optimism. The stewardship campaign has produced an increase of \$22,000 in estimates of giving over what was anticipated for last year. Overall, it is anticipated that income for 2023 will surpass last year's by \$33,000—an increase of more than 20%.

Even with the increase of income, we may still have more expenses than we can cover with our income. The budget anticipates a deficit of nearly \$10,000. We are prepared to pay for this potential shortfall through our reserve funds of more than \$90,000 held in the money market account. We also have investment accounts with nearly \$200,000 which we do not expect to spend.

PASTOR'S REPORT

"See, I am doing a new thing! Now it springs up; do you not perceive it? I am making a way in the wilderness and streams in the wasteland." (Isaiah 43:19)

January and February of 2022 made it feel like we would continue in the COVID wilderness yet another year – we were wearing masks and trying to social distance. Some were still hesitant to return to worship. COVID exhaustion had set in for all of us. One of the benefits of having over thirty years experience as a pastor is knowing the ebb and flow of church experience, and to hang in there and see what God might do next.

Tom and David continue to be a blessing and take care of so much for the church.

Melissa persevered through COVID when our singing group numbers were low. Her efforts were rewarded in 2022 as our Alter-Notes group has grown to its largest attendance in years! Brian continued his faithful service at the organ/piano and in worship music planning. Mark has been great as a second organist/pianist who fills in as needed.

Our Sunday school teachers faithfully served us for 2022. Jeni and Audra have brought stability and competence to us. It is because of them that parents feel comfortable bringing their children to church. We have had more children attending this past year than any year I can recall.

I thank God for the "new thing" we experienced this past year. We look forward in faith and hope to 2023. It bodes well that our estimates of giving received during the stewardship campaign exceeded any year since 2015 and probably well beyond that!

Finally, I thank all who served on our church Cabinet during a tough year of COVID decisions, our treasurer Julie and clerk Suzanne, and our co-moderators who shepherded us through the year – Bill and Linda.

I am grateful to serve as pastor of our congregation. Jay

CO-MODERATORS' REPORT

Our Cabinet in 2022 was efficient, effective, and a complete pleasure to work with.

Treasurer Julie McCurdy continued to provide clear, accurate, and timely financial reports each month. Our Clerk, Suzanne Broussard, diligently recorded and distributed the minutes from our monthly meetings. Ministry leads – Tom Macy for Physical Resources; Becky Bryant for Outreach; Patty Lantrip, Mary Davidson, and Helen Barnard for Welcoming; and Sandy Znetko for Called to Care – kept our ongoing ministries in operation and reported their activities to the Cabinet each month. Education lead was Lisa Barnes along with committee members Linda Mast and Alice Kring. After Lisa relocated outside our community mid-year, Pastor Jay and others in the congregation served to continue educational programs throughout the year.

A note of special thanks to Mary Davidson and Helen Barnard, who took over leadership of the Welcoming Ministry from Patty Lantrip part-way through the year.

Special thanks, too, to Linda Mast, who signed on as Co-Moderator in June. Linda will lead the Cabinet, along with Sandy Znetko, in 2023.

Our committees – Music, Budget, Nominating, Stewardship, Church Relations – did an excellent job of carrying out their duties. Special thanks to Patty Lantrip for succeeding so well at recruiting Cabinet members for 2023.

In addition to maintaining the month-to-month operations of the church, the Cabinet in 2022 worked on a number of *ad hoc* projects, including finalization of a facility use agreement, establishing security procedures, acquiring an AED, conducting a property inspection, and other items. At-large member Angela Imbierowicz, for example, used her legal background and experience to guide the Cabinet through its consideration of an outside request to rent parking spaces (the Cabinet declined the proposal). Special thanks to Melissa Gates and Tom Macy for their work on the facility use agreement. Melissa took the lead in meeting a variety of security challenges in 2022. She has assembled a team and established procedures that ensure the safety of our property and congregation.

The Cabinet conducted two "visioning" events in the fall, soliciting from the congregation their ideas for where FCC/UCC of Prescott should head next. Results from those sessions are included in this Annual Report. Heading into 2023, I sense much optimism, new energy for enriching our church family, and new passion for reaching out to our community. The church's vision and optimism are reflected in the budget the Cabinet proposes for the coming year.

After two years as Co-Moderator, it's my turn to rotate off of the Cabinet. I have every confidence in the capabilities and dedication of the 2023 Cabinet, and I'm eager to see what happens next. Thank you for allowing me to serve.

TREASURER'S REPORT on financial position and activity in 2022

From a financial perspective, the year 2022 began and ended much as expected. Income from congregational giving was strong and steady and exceeded the anticipated income budget. Total income for the year was \$154,023.

Total expenses reached \$151,149 which is 96% of the expense budget. Income exceeded expenses by \$2,875.

Some expenses worth noting include:

- Purchase of AED unit (automated external defibrillator) for \$1,222. This purchase was entirely supported by funds donated for that purpose.
- Now using QuickBooks Online for tracking our finances. Previously we used a desktop version of QuickBooks.
- As expected, our investments with United Church Funds have not increased in value this past year. Market value loss was \$19,614.

Current assets include \$145,919 in bank accounts and cash-on-hand. Investments are valued at \$198,224.

I wish to express my gratitude to the counting teams who are greatly underappreciated for their diligence and dependability in tabulating and depositing each week the cash and checks received as donations to our church. These people keep our church operating! Susan Lemons oversees the counters and reports the income to the treasurer. She tracks the gifts by donor and sends out quarterly statements to donors as acknowledgement of their gifts and for tracking their payments toward their estimated giving. Thank you, Susan! I couldn't do my job without you!

EDUCATION

The on and off nature of COVID concerns and restraints presented a challenging year for education. The education committee for 2022 included Lisa Barnes, Alice Kring and Linda Mast. Early in the year, a survey of the congregation was completed to get some ideas for areas of interest for educational programs. The results identified the following as topics of interest in rank order:

We hope to be able to return to more face-to-face programs in 2023 as it becomes possible based on continued COVID constraints.

Back by popular demand, Pete Norum led a series of in-person educational programs on progressive Christianity including video and lively discussions beginning with Lent and then continuing through the summer. We are grateful to Pete for his faithful service to facilitate these programs.

Pastor Jay held a Saturday Zoom faith forum throughout the year, and a Friday Zoom Bible study for some of the year.

Jeni and Audra served faithfully as our Sunday school teachers and their competence and teaching led to an increase in our Sunday school attendance. We look forward to continuing opportunities in 2023 to engage our growing numbers of children with new emphasis on middle school age as some of our children are reaching that age.

We continue to be inspired by new suggestions for educational opportunities for our congregation for all ages that have evolved from our Visioning 2023 discussions.

MUSIC

We had a large donation of choral music from a church in Phoenix. It is gradually being organized. Next, we need to read through the pieces to see what we can use. Most are easy to moderate in difficulty.

OUTREACH

Local/Regional Mission Projects/Programs

Coalition for Compassion and Justice (CCJ)	
CCJ has transitioned from primarily being an emergency shelter. It now seeks to help homeless clients find permanent affordable housing in mobile homes, apartments, cottage homes, and lodge style housing. Dozens of previously homeless clients now proudly have their own housing. Rental assistance is available on the basis of a sliding scale. Additionally, CCJ works with clients needing counseling and help in finding employment. Together with the city of Prescott, a "Prescott Worker's Progress Agency" has been established wherein clients are trained and employed to perform landscaping projects throughout the community.	
DACA Fund\$1,121	
This fund helps local legally-documented immigrant students meet their education expenses. This past year donations were given to the Prescott Community College's "Freedom Education Fund" (scholarship aid for DACA students) and to Franceny Gardea Gutierrez. Franceny is now working to earn her master's degree in Critical Psychology.	
Discovery Gardens Preschool (DGP)\$919	
DGP welcomes all children, including those who are developmentally challenged. Our donated dollars help support the needs of low-income families needing tuition assistance.	
Frontera de Cristo\$320	
An ecumenical border ministry in Agua Prieta, Mexico (across the border from Douglas, AZ), Frontera de Cristo provides shelter, counseling, food/clothing assistance, education classes, and job training for migrants choosing to remain in Mexico.	
Giffords\$400	
Giffords is an anti-gun violence, non-profit organization (based in Arizona, founded by Gabby Giffords) working to mobilize lawmakers and constituents in support of gun safety.	
Prescott Area Habitat for Humanity (PAHFH)\$2,025	
With the help of the homes' future residents, PAHFH volunteers construct homes for those living at or below the Federal Government's Poverty Level Income figures.	

Prescott Area Shelter Services (PASS)\$775
PASS provides shelter for women and children. Volunteers from our church provide a monthly hot meal, along with snacks, personal hygiene products, and laundry supplies. We are thankful for all of our PASS volunteers and to Patty Gard, PASS Team captain for the majority of 2022. Carolyn Christians has taken over for Patty in 2023.
Prescott Community Cupboard (PCC)\$2,295
PCC volunteers have been busy packing and distributing food bags to individuals and families needing food assistance. PHYSICAL RESOURCES

Still impacted by covid 19, the Church continues to work to be all that we want to be to serve our community and God. We have been blessed by the addition of many new people to our congregation and while our numbers have not grown, the new members have enabled what the Church is able to do to start moving forward. Praise God!

Our old building was kind to us this past year and did not give us major problems.

Our pest control company decided to eliminate their Prescott clients in August (both of them). They did not call or write; I had to call them to find this out. Was not too impressed with them as last summer two days after they were here, we had a bad infestation of ants in the sanctuary and Perkins Hall. David and I were able to get it under control. We decided to be the pest control people and so far, we are having no problems. We will see what spring brings.

Our irrigation system has not worked properly for a couple of years and David was doing all the watering himself. This monsoon we were blessed with abundant rain and in August we were put in contact with Cactus Wren Landscaping who was able to fix our irrigation at a very reasonable price.

Our front garden area looks better than ever.

Coolers were turned on in April and off in late October. We did not need to replace pads this year but will need to in the Spring. The furnaces were given a thorough check up in October as that had not been done for three years. Two thermostats were replaced in the fall that were no longer working. We are having problems with a couple more that can no longer be programmed. I plan to have the remaining six replaced in January.

We had a walk through done of the two buildings in September to see what potential areas need to be addressed. The contractor that does repairs for the foundation was used. Aside from both roofs being in their last years (27 years old), minor things were found and are being taken care of. Replacing both roofs should be addressed in 2023. No problems now, but should we wait until we have problems?

The Lion's Club had their pancake breakfast in June after two years away. They had about one half of the previous diners.

We still have no groups other than the Scouts meeting in our building. The groups I have talked to are doing combination meetings with in-person and Zoom participants. We have added a booster to our wi-fi that might enable groups to get a signal.

The fact that groups are not meeting means that cleaning supplies costs are lower than normal.

There was interest from a company on Marina to rent twenty spaces in our parking lot. This would have been from 8 until 5, Monday through Friday. After much discussion, the cabinet voted against the proposal.

David is completing his fourth year with us. Many thanks for all he does to keep this old building in good repair and clean. He is a treasure and good to work with.

STEWARDSHIP

The stewardship campaign of 2022 included campaign materials, educational items for the bulletin and *The Parish Caller*, and speakers to present a stewardship minute during worship in November. Julie McCurdy led the budget committee in creating the proposed budget. The proposed budget and education materials were presented to the congregation during November. Estimates of giving were received, totaling \$132,135 by the end of the year. There were 46 giving units representing 65 people. As a comparison, 2022 estimates of giving totaled \$109,140 – 45 giving units representing 61 people. There was an average giving amount increase of \$513 from last year.

FOUNDATION Annual Report 2022

The elected Foundation Board members for 2022 were David Foote, President; Jim Robinson, Vice President; Jim Christopher, Secretary; Susan Lemons, Treasurer; Alice Kring; Patty Lantrip; and Sue Hodge-Parker. Other members were Tom Macy, Chair of Physical Resources, and Pastor Jay Wilcher.

Our first full year with Red, White & Brew ("RWB") as a tenant in our building has gone very well. They have always paid the monthly lease a few days early and their business seems to be doing very well. The corrugated roof over the front part of the building was replaced early in the year and the area between our building and our neighbor's building next door at 212 E. Gurley Street was cleaned out, sealer applied to our foundation and then the area was sealed with concrete to prevent future leaks and facilitate keeping the area clean. No leaks have occurred in that area since the work was completed.

During a summer storm a big branch from our Neighbor's tree broke off and damaged a corner of the new red metal roof. It was repaired, but that area of the building may need ongoing attention.

In early December we met with management from Hassayampa Inn to discuss problems with drainage water running off our property and creating some issues with their parking lot. This issue will be properly addressed prior to the 2023 Monsoon season.

The Foundation provided a check for \$366.72 from the Clay and Elsie Smith Memorial Endowment Fund for use in benevolences.

At each regular meeting the Board received and reviewed financial reports from its accountant Amy Jaspers. For the quarter ending September 2022, the Foundation's assets totaled \$1,446,704 compared to \$1,620,029 for the corresponding quarter ending September 2021. The reduction in Foundation Assets reflects the losses in the stock market during the last 12 months. The Board evaluated whether any changes should be made to investments within our portfolio and determined that the current holdings are still appropriate and decided not to make any changes.

The third quarter 2022 financial report (ending September, the most recent quarter) and the fourth quarter 2021 financial report (ending December, the most recent full year report) with assets, liabilities and fund balances are included as part of this annual report. Annual fourth quarter reports are not typically available until late in January, after the Church Annual Meeting.

The Board expects to hold regular quarterly meetings on February 16, May 18, August 17 and November 16, 2023.

First Congregational Church Foundation Funds

Second Century Fund

This Fund is comprised of the commercial property and the net income derived from the property, less any Foundation expenses. The Foundation Board has designated that the net income will be divided into two parts: 2/3 for major capital expenditures by the church, special large new programs and major addition of personnel of the church, and 1/3 for current capital needs. The Foundation Board can at any time elect to redesignate how the fund balance and its future net income will be divided.

Christian Education Director's Fund

As a non-endowment fund, it can be used to fund non-budget supplementary Christian Education programs and personnel.

First Congregational Church Foundation Fund Honoring J. Leland and Marie Taylor Mills

These funds should be unrestricted use for the benefit of the Church and disbursements by the Foundation Board should take into account the continuing ability to support the Church's need in the future.

Charles E. Schott Memorial Endowment Fund

The Foundation Board may use this income for: (1) any activity conducted within the church building and which is authorized by the congregation, by the Cabinet, or by any duly created committee of the church, excluding any expenditures connected with community benevolences and charities, (2) capital improvements to the church property, (3) any activity which will benefit the children, the youth and young families of the congregation.

Clay C. and Elsie E. Smith Memorial Endowment Benevolence Fund

The interest from this endowment fund is to be used for church benevolence. The income, including capital gains, of this fund must be spent annually.

Raymond E. and Betty Shire Memorial Endowment Fund

The interest on this endowment fund can be spent after the fund attains a value of \$10,000.

Phyllis J. Wells Wood Memorial Endowment Fund

This fund can be spent for worthwhile church purposes as the need arises, with the Foundation determining the merit (or need) of the funds requested.

Keith Quail Memorial Endowment Fund

Established in 2006 as an endowment fund, the Foundation Board can spend the income as it sees fit within the restrictions of the bylaws.

Foundation Memorial Endowment Fund

The interest on this endowment fund can be spent according to the by-laws of the Foundation and directors of the Foundation Board when the fund attains a value of \$20,000.

Webb Family Endowment Fund

There are no restrictions on this fund.

Pat Welch Fund

Fund is to be used as directed by the Cabinet.
